# AAFB GENERAL ORDER #1

## 4. PROHIBITED ACTIVITIES: The following activities are prohibited at all times:

- a. **Abandoning Vehicles.** All vehicles registered to AAFB personnel and their families must be sold, lawfully transferred (to include giving a power of attorney to a willing recipient who agrees to accept full responsibility to properly dispose of the vehicle), other legal disposal (such as disposing at a junk yard/scrap yard), or shipped off Guam prior to official movement from Guam (e.g., PCS, separation from service, etc.). In addition to facing potential disciplinary action, violators may also be subject to financial liability for any costs incurred by the 36<sup>th</sup> Wing as a result of disposing abandoned vehicles.
- b. **Abandoning Pets.** All pets brought to or acquired while residing on Guam must depart the island with the owner or be lawfully transferred to another owner or local animal shelter prior to departure from Guam. Owners will ensure the proper registration, feeding, and oversight of animals in their care. Animal Abandonment is also a criminal violation of Guam Law (9 GCA §70.50) and Article 134, UCMJ (Animal Abuse – specifically includes animal abandonment). In addition to facing potential disciplinary action, violators may also be subject to financial liability for any costs incurred by the 36<sup>th</sup> Wing to remove abandoned pets from the base.
- c. **Use of Vape Pen Devices, Electronic Cigarettes, or Other Similar Smoking Products Belonging to Another Person (MILITARY PERSONNEL ONLY).** Borrowing vape pens or other similar devices increases health risks as devices may contain unlawful or unsafe substances. Military personnel are prohibited from using an electronic cigarette, vape pen device, or other similar product that belongs to another person.

#### DRIVING UNDER THE INFLUENCE & OPEN CONTAINER

THEN LOCAL RIDE-SHARE APP ON GUAM IS CALLED STROLL HOWEVER, DURING PEAK WEEKEND HOURS, STROLLS CAN BE HARD TO COME BY. TAXIS ARE AVAILABLE BUT SOME ONLY ACCEPT CASH. GUAM HAS NO PUBLIC TRANSPORTATION. ENSURE YOU HAVE A PLAN FOR A WAY HOME BEFORE CONSUMING ANY ALCOHOL. AIRMEN AGAINST DRUNK DRIVING IS AVAILABLE IN CASE YOUR PLAN FALLS THROUGH. THEY CAN BE REACHED AT (671) 366-7433 AND TYPICALLY RUN FRIDAYS AND SATURDAYS FROM 2200 TO 0300. OPEN OR UNSEALED ALCOHOLIC BEVERAGES ARE NOT PERMITTED IN THE PASSENGER AREAS OF THE VEHICLE SO MAKE SURE TO FINISH OR DISPOSE OF ANY DRINKS BEFORE GETTING IN.

#### SPEEDING & DRIVING FATALITIES

SPEED CONTRIBUTED TO 5 DRIVING FATALITIES SO FAR THIS YEAR. THE MAXIMUM SPEED LIMIT ON THE ISLAND IS 35 MPH. GUAM ROADS BECOME SLIPPERY WHEN WET, INCREASING THE POTENTIAL FOR ACCIDENTS. EXERCISE CAUTION WHEN DRIVING, ESPECIALLY IN AREAS WITH POOR LIGHTING WHERE PEDESTRIANS AND WILDLIFE MAY NOT BE EASILY SEEN.

#### DRUNK/DISORDERLY CONDUCT & ASSAULTS

THERE ARE SEVERAL BARS AND CLUBS IN TUMON THAT ARE A "HOT SPOT" FOR MILITARY MEMBERS. THERE HAS BEEN AN INCREASE OF REPORTS OF BAR FIGHTS AND BRAWLS AT THESE LOCATIONS. EXERCISE CAUTION WHEN VISITING BARS AND REMOVE YOURSELF FROM DANGEROUS OR ESCALATING SITUATIONS. IF YOU ARE UNDER 21, DO NOT CONSUME ALCOHOL AT THESE ESTABLISHMENTS REGARDLESS OF YOUR ABILITY TO ENTER.

#### ILLEGAL DRUG USE

MARIJUANA & CBD ARE LEGAL TO POSSESS AND USE ON GUAM HOWEVER, POSSESSION AND USE BY MILITARY MEMBERS REMAINS PROHIBITED. TAKE CAUTION TO READ THE INGREDIENTS BEFORE PURCHASING ANY COFFEE DRINKS, SMOOTHIES, OR VAPES. IN ACCORDANCE WITH GENERAL ORDER NO. 1 AT ANDERSEN AFB, THE USE OF ANY VAPE OTHER THAN YOUR OWN IS STRICTLY PROHIBITED.

#### ILLEGAL ACTIVITIES

THERE ARE MANY MASSAGE PARLORS AND NIGHT CLUBS WHERE ILLICIT ACTIVITY MAY OCCUR. MEMBERS SHOULD AVOID MASSAGE PARLORS LATE AT NIGHT, ESPECIALLY THOSE THAT ADVERTISE 24/7 OPERATING HOURS.

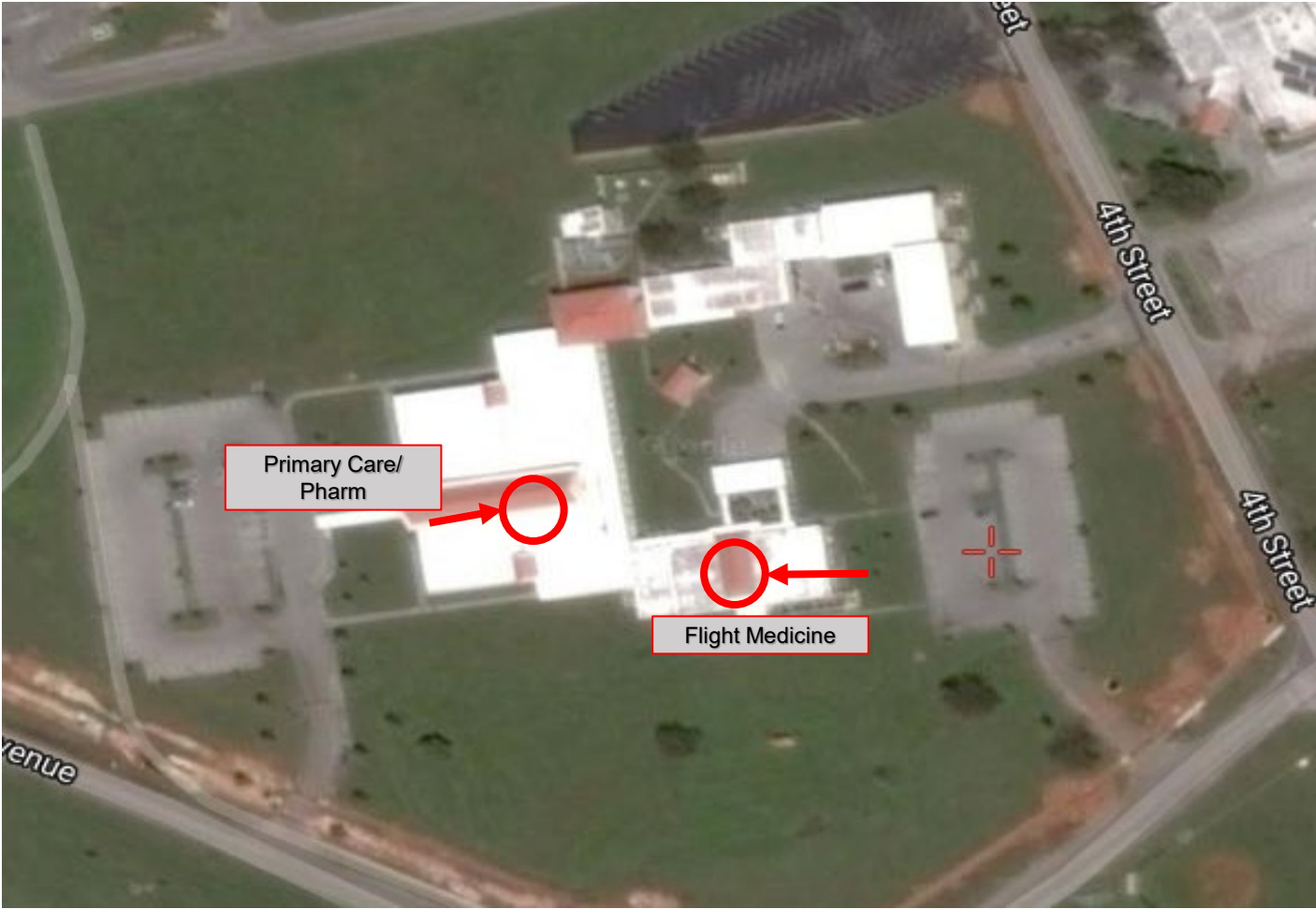
# PUBLIC HEALTH

- **Protect Yourself**
  - **Wear PPE** (i.e. hearing protection)
  - **Wear insect repellent**
  - **Hydrate! Hydrate! Hydrate!**
    - Guam is hot/Humid
- **Notable Health Concerns**
  - **STIs** – AAFB averages 16 new cases a month
  - **Tuberculosis** - Active TB on Guam is **10x higher** than CONUS.
  - **Hepatitis B & C**
  - **Leptospirosis**
  - **Giardiasis**
- **Animals to Avoid**
  - **Hazardous marine life** (man o' war, etc.)
  - **Stray animals** (dogs/cats, etc.)
  - **Cane Toads**
  - **Brown tree snakes**

# Privileged Providers

- ICTB (Interfacility credentials transfer brief) from sending MTF
  - **Required** for practice at affiliate MTF (Andersen) including access to systems and ancillary services (lab, rad, pharmacy).
  - **Providers MUST contact primary Credentials Manager** to initiate ICTB application (provide copy of TDY orders to ensure correct dates)
  - **Providers MUST submit** ICTB application **two (2) weeks prior** to departure

## Recap – Required Provider Documents



### ICTB-Package



#### DoD CAC Card

The provider must have a current DoD CAC card that goes beyond the end date of deployment.



#### BLS a/o ACLS Card

The provide must have a current BLS card that goes beyond the end date of deployment.



#### Copy of Orders

The provider must always have a copy of their orders.



#### Copy of signed ICTB

The provider must have two copies of a signed ICTB, one to keep and one to provide to the duty location.



#### Copy of approved duty AFSC privileges & civilian privilege list

The provider must have two copies of approved duty AFSC privileges, one to keep and one to provide to the duty location.

# Clinic Reporting Procedures

**Squadron Medical Elements (SME) will coordinate care with their members.**

**\*\*Do not instruct members to report to the clinic without an appointment with their SME\*\***

**\*\*SMEs will provide sick call for exercise participants only**

- **Ancillary services are available with a valid MHS Genesis encounter/order**
- **If not registered in MHS Genesis, present to the Tricare Office in the 36 MDG with the following information (required for mini-registration and correct characterization of apt type, prior to patient being seen at the clinic):**
  - Full Name
  - DOB
  - DODID Number, SSN, Foreign ID equivalent
  - Sex
  - Orders (CED, Foreign, TDY, etc)

# Vehicle Operation

**Seatbelts are required!**

**Drinking & Driving is illegal!**

- Have a plan: Wingman, DD, or AADD (366-RIDE)

**No cell phones while driving – hands free only**

**Speed limits**

- 35 mph max for Guam
- 35 mph unless otherwise posted on base
- 15 mph in school, housing and construction areas on base
- 10 mph in parking lots on base





## Road Hazards On & Off Base

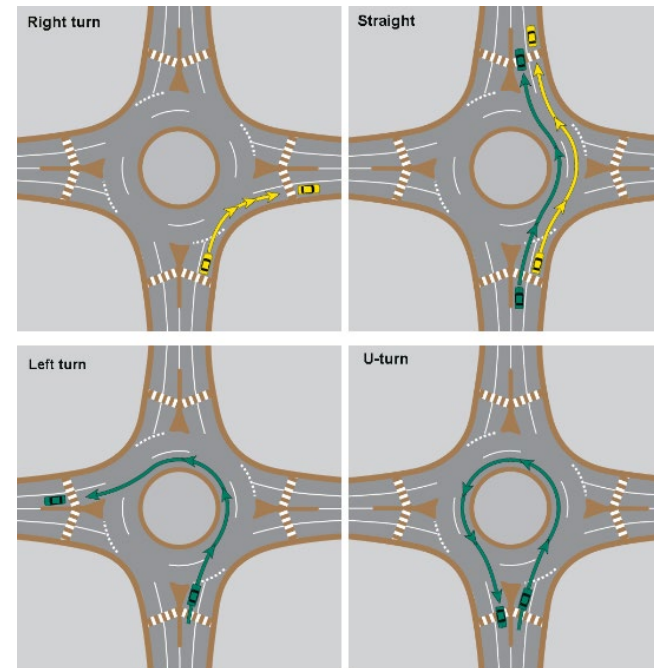
- Slippery when wet

- 3 on Andersen AFB
- Yield to traffic in the circle

- Traffic Environment





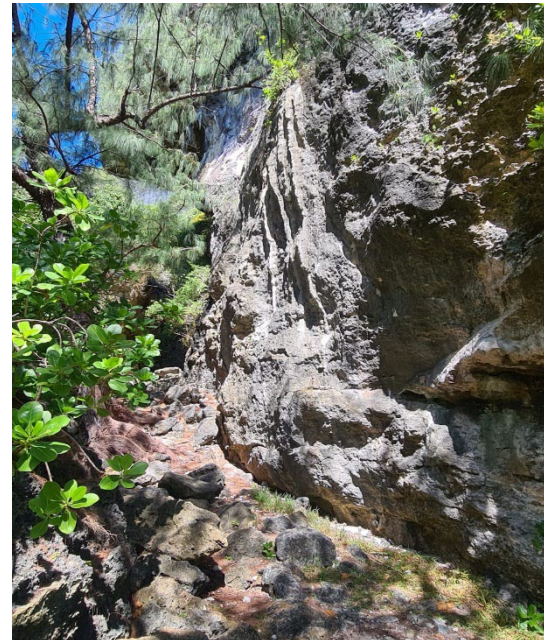

# High Risk Activities

- **All PACAF military personnel who participate in High-Risk Activities must inform their immediate supervisor or commander of their intent**
- **Completion of AF Form 4391, *High Risk Activities Worksheet*, is required.**
- **Checklist provided on the Wing Safety SharePoint**
  - **PACAF High Risk Activities Program Guide**
- **Supervision's role does not replace individual's responsibility.**
- **Use sound judgment and risk management to preserve life, limb, and the ability to perform your duties.**

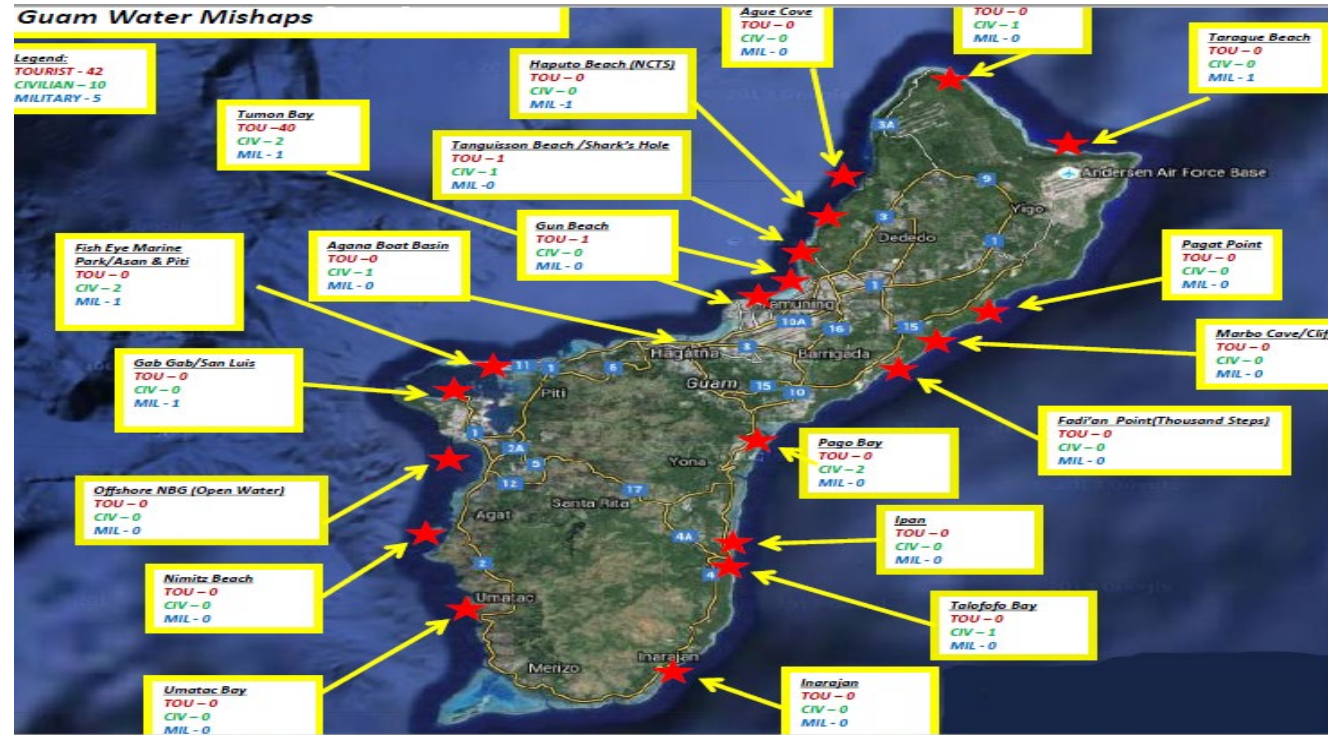

# Water Restrictions

- Military personnel are **prohibited** from the following activities:
  - No cliff diving anywhere in the islands
  - No reef walking
  - No swimming under “red flag” conditions (beach specific)
  - No Swimming or fishing in the vicinity of the reef/breakwater
    - SCUBA okay if certified.
  - No Cave Diving/Underwater Exploration (overhead environments)
    - SCUBA okay if certified
- Additional Items
  - Minimum 2 swimmers required for all ocean related activities
  - Have a plan and intervene before things go wrong

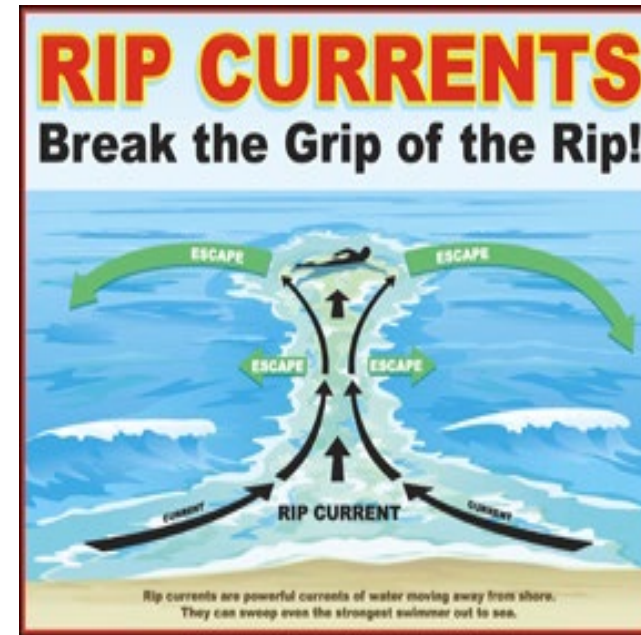


# Rip Currents

## Critical Days Of Summer

Caught in a  
Riptide?  
Remember...

- Don't panic and remain calm
- Don't swim straight back to shore
- Don't try to swim against the current
- Remove yourself from the current by swimming perpendicular to the current (parallel to the coast)
- Once you see a break in waves, you may be able to swim/climb over the reef & swim to shore
- If the water is too deep or the current is too strong for you to hold yourself in place, let the current take you and it will eventually slow down as you float further from the coast, then swim parallel to the coast for a few feet and then swim back to shore.





# Mishap Reporting

- Mishap reporting
  - Notify your supervisor immediately or ask for help
  - Contact Command Post @ 366-2981
  - Fill out AF Form 978
    - Route to CC via Unit Safety Representative (USR)
    - USR submits AF Form 978 to Wing Safety

**Call 9-1-1 for emergencies – inform dispatch that you are on AAFB.**

- Report all hazards to 36 WG Safety at 366-SAFE

## Key Definitions

- **Consent:** freely given agreement
- **Sexual Harassment:** unwelcome sexual requests, sexual advances, deliberate/repeated offensive comments/gestures of a sexual nature
- **Sexual assault:** intentional and unwanted sexual touching (or attempts to) in erogenous areas without consent.
- **Retaliation:** wrongfully takes or withholds (or threats to) adverse or favorable personnel actions





## WHO WE SERVE

- **Sexual Assault services:**
  - Active-Duty military and dependents 18+
  - AF Reserve and ANG members in Title 10 Status
  - \*\*\*NEW Policy\*\*\* DAF Civilians (appropriated & non-appropriated) & Dependents 18+ (Both Restricted & Unrestricted Available)
- **Sexual Harassment services:**
  - Active-Duty Airmen, Guardians, and Reserve members 18+
  - Air National Guard (ANG) members in Title 10 Status
  - Members can still go directly to EO if they do not want ADVOCACY services

Regardless of the eligibility to be able to make an unrestricted or restricted report, everyone (civilian or military), has the ability to report a sexual assault or other criminal activity to AFOSI

- *Commanders (Any)*
- First Sergeants
- Chain of Command
  - Flight Chief
  - Superintendent
  - Direct Supervisors
- DoD Law Enforcement
- EO Office



# Sexual Assault

## What if it happens to you?

- Get to a safe location immediately
- Seek medical attention ASAP (**Navy Hospital**)
  - Don't eat, drink, use the restroom, change clothes, etc., prior to medical exam
- Contact the SARC
  - **Call the 24-hour sexual assault help line: 366-SARC (7272)**

## What if it happens to a friend?

- Take care of any immediate needs (medical, safety, emotional)
- Listen. Be calm, control emotions, and non-judgmental
  - Each survivor copes in a different way
  - Immediate reactions may include: crying, laughing, hostility, confusion, withdrawal, or outward calm
  - Common responses are to fight, flight, or freeze
  - There is no “right way” to respond to an attack
- Let the victim make their own decisions, but help them to make an **INFORMED** decisions
- Encourage him/her to seek assistance



# REPORTING OPTIONS

## ■ Restricted

Enables AD military victims and their dependents over age 18 to report sexual assault confidentially to a *Sexual Assault Response Coordinator (SARC)*, healthcare provider, or victim advocate **without initiating an investigation**

- The SARC and SAPR VAs are not mandatory reporters; even if there is collateral misconduct.

## ■ Unrestricted

The victim can make a report through their chain of command, law enforcement (SFS, AFOSI or sister-service equivalent), SARC, victim advocate, or healthcare provider

- An **investigation will take place**

## ■ Independent

Information about a sexual assault is disclosed by a **third party** and an investigation may be launched



## EXPANDED ELIGIBILITY for RESTRICTED REPORTING

- Victims can file a Restricted Report even if:
  - They disclose the sexual assault incident to their chain of command
  - OSI has a 3<sup>rd</sup> party investigation
  - OSI investigation is closed (Victim can retain benefits for SAPR advocacy services i.e. mental health, SVC, etc.)
- However, non-Law Enforcement (LE) victim(s) are not eligible to file a Restricted Report if they speak to law enforcement and/or OSI.
- \*\*\*NEW Policy\*\*\* LE victims or adult family members 18+ can disclose sexual assault to another LE member in a personal conversation and still file a RESTRICTED SA Report.
  - Recipient can not be in the victim's chain of command and must ask the victim if he/she wants the info to remain private

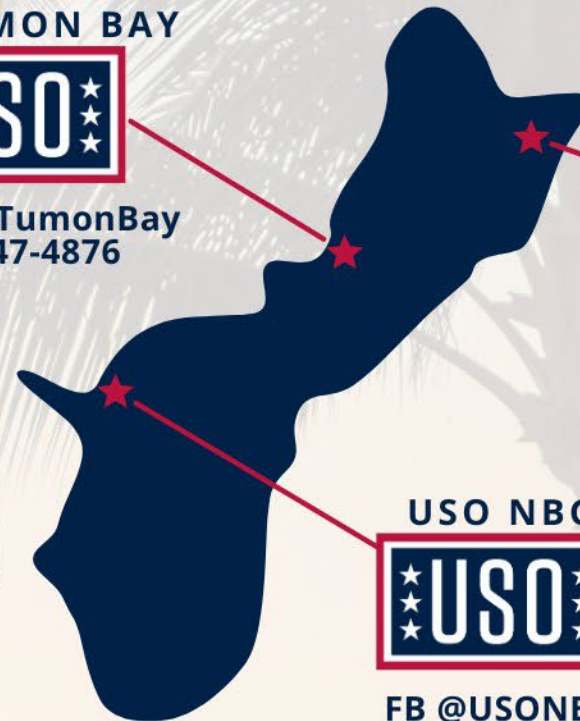

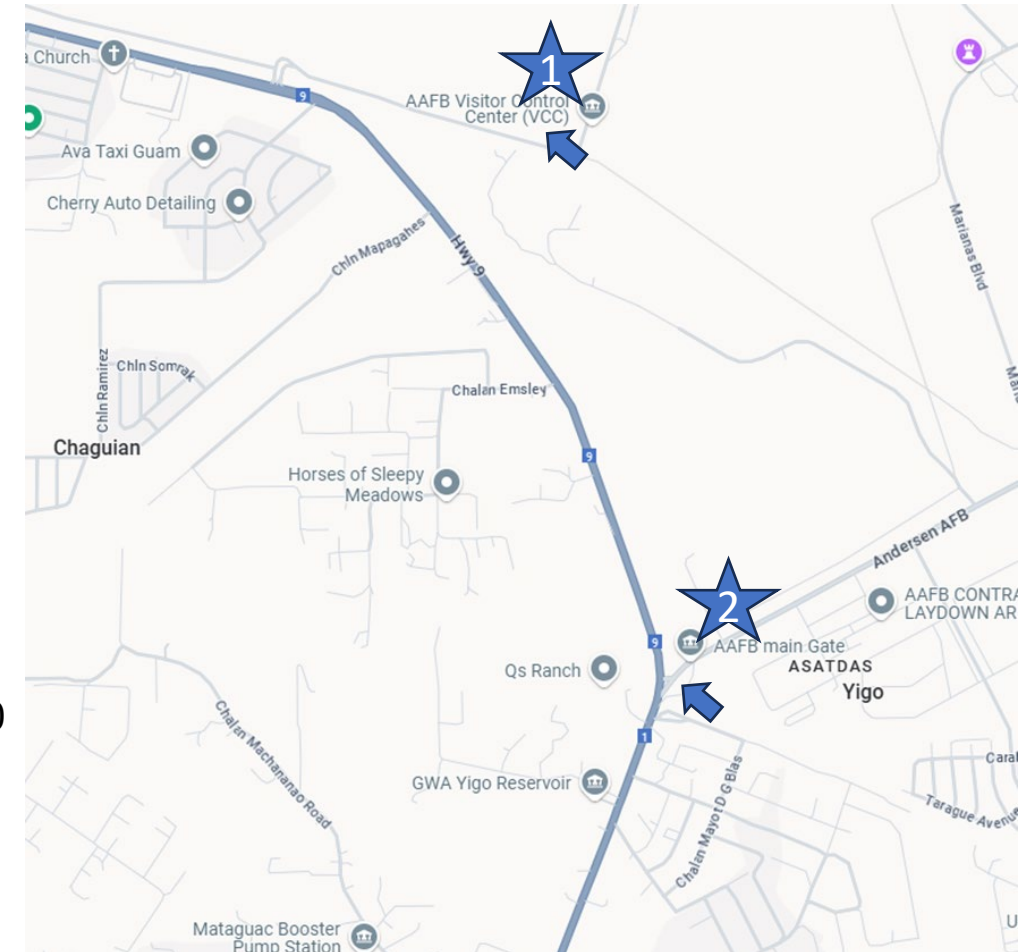
# General Information

- ❖ Only enter areas you are authorized access to via Entry Authority List (EAL)
- ❖ Only use authorized flightline pedestrian/vehicle access points
  - ❖ **NOTE: If you have any additions to an existing EAL or need an EAL for flightline access, please contact 36 OSS personnel at 366-1008**
- ❖ Photography is authorized in Restricted Areas when accompanied by an EAL authorizing photography approval letter signed by the Group Commander of that Restricted Area.
- ❖ The 36 OG/CC will be the approval authority for any flightline photography requests.
  - ❖ **NOTE: If you need authorization, please contact 36 OG/CSS personnel at 366-3664**
- ❖ Once your request is approved, ensure you have the authorization on-hand. Prior to taking photographs, ensure you notify Base Defense Operation Center (BDOC)
