## **Base Access Entry Policy**

BLUF: Beginning **01** August **2019**, Andersen AFB will be utilizing updated Identification criteria for all base visitors. These measures are intended to bring the installation in compliance with REAL ID Act and the most current USAF policy guidance.

BACKGROUND: AFMAN 31-113, *Installation Perimeter Access Control*, para 2.6, states "Individuals receiving a locally produced installation access credential must have a validated need to enter the installation and be properly sponsored. The visitor must submit to applicable identity proofing, vetting to determine fitness, and conform to USAF protocol requirements for physical access and credential/screening standards."

DISCUSSION: In compliance with AFMAN 31-113, and the REAL ID Act, 36 SFS/VCC will recognize three categories of authorized identification credentials. Any one form of ID within **Category A** may be used as sole source for identity proofing and a visitor pass issued the same day. Two forms of **Category B** credentials may be used for identity proofing, and a visitor pass issued the same day. **Category C** credentials are accepted, but require an accompanied state or federal issued photo ID, an identification and background screening questionnaire, and require a 3-5 duty day wait time for identity proofing and vetting.
