SUBJECT: Andersen AFB Supplemental Restriction of Movement (S-ROM) Policy

References: (a) 36 WG/CC, 14 Jul 2021, AAFB Restriction of Movement (ROM) Procedures
(b) 36 WG/CC, 16 May 2021, COVID-19 Mitigation Measures & Enforcement

1. All DoD-affiliated personnel traveling to AAFB will conduct ROM upon arrival IAW reference (a) with exception to para 3.c and 4.b. TDY personnel participating in Summer 2021 Exercises and Operations will conduct S-ROM unless fully vaccinated or fully recovered. Presentation of a negative COVID-19 RT-PCR test result will NOT be a valid exemption from S-ROM.
2. All non-vaccinated personnel will conduct a Supplemental ROM (S-ROM) for 10 full days. S-ROM will be conducted IAW this memorandum, reference (b) and any other amendments or supplements that may be released after this memorandum is signed.
3. Non-vaccinated personnel lodged on AAFB are restricted to the areas identified as their lodging and their place of duty while in S-ROM. Non-vaccinated personnel may conduct activities according to the table below unless more restrictive direction is given.
