Major Joshua A. Rummel is the Deputy Staff Judge Advocate, 36th Wing, Andersen AFB, Guam. As the Deputy Staff Judge Advocate, he assists the Staff Judge Advocate in providing legal services to a wing consisting of five groups, 17 squadrons, and 8,500 military and civilian personnel providing the President of the United States sovereign options to decisively employ airpower across the entire spectrum of engagement from America's premier forward operating location.

Major Rummel previously served as a Ground Radar Systems Technician with the 34th Combat Communications Squadron at Tinker AFB, OK. He received a direct commission as an Air Force judge advocate in September 2013 and re-entered active duty in October 2013. In addition to being a certified AOC crew member, Maj Rummel is a qualified Air Advisor. He is admitted to practice law before the Supreme Court of Oklahoma, the Court of Appeals for the Armed Forces, and the Air Force Court of Criminal Appeals.
